FUNDRIASER RULES 2007

1. COOKED ON SITE

All meats that are entered into judging will be cooked from scratch within the constraints of the event. Pre-cooking, pre-marinating, etc. will not be allowed either on or off the cook site of Bass Pro Shop, Grapevine parking lot prior to start of the official cooking to begin. This will begin at the conclusion of the mandatory cooking team meeting which will take place at the pavilion promptly at 8PM on Friday, October 26, 2007.

NO Meat may be removed from Ice storage until the site judge arrives for inspection. This is a very serious rule from the Health Department on our Food permits. Only after your team has been officially checked in (No earlier than 6:00 PM, Friday, October 26, 2007), and the site judge has inspected your area. Following your site check, your meat can then be seasoned and wrapped.

Mandatory working meat thermometers are required at each cooking team site.

2. SANITATION

All cooks are to prepare and cook in as sanitary manner as possible. Cooking conditions are subject to inspection by the judging committee at any given time. This is a very serious rule from the Health Department on our Food permits. All cooking teams must comply with proper food handling techniques which include keeping food items covered. Lids are not supplied by the promoter.

3. BBQ COOKING TEAMS

A Cooking Team can consist of one, two, or three teammates. One person per each team shall be named as the "Team Captain" and will be responsible for making sure the team is in compliance of all rules and regulations. A teammate being unruly or inappropriate is grounds to have the entire team forfeited from competition and could result in asking the team to leave the premises. This is a Fundraiser in which a non-profit organization, Camp Craig Allen, is conducting this BBQ Cook-Off in which you and your team mate's actions could reflect onto such organization.

Multiple entries in the same category by the same team will NOT be allowed. A Team may enter one or all of the categories, but must be registered in the particular category before contest begins.

4. COOKING PROCESS

Any commercial or homemade trailered or untrailered pit or smoker may be used. Gas, electric and electric rotisseries will be allowed. No ground pits or open fire pits or grills with any open flame are permitted.

Promoter included this information in the registration and non-compliance will be grounds for disqualification.

Smoking of all meats will be throughout the night Friday and into Saturday. Upon official cooking start, one team member must remain in your cooking area at all times.

Only designated Volunteers, Judges and Cooking teams are to handle the meat in preparation, cooking, slicing, and serving. Teams are able and recommended to give very small samples of their cooked meat, with the intent to encourage BBQ sales for the fundraiser event which will be sold at the designated food booths.

4. COOKING TEAM MEETING

A MANDATORY cooking team meeting will take place at the pavilion in front of the stage promptly at 8 PM on Friday, October 26th. All Teams must be at this team meeting with all of their teammates. After the welcome by the Founder of Camp Craig Allen, the Head Judge will address the cooks, review the competition rules and provide the information on the judging procedures for Saturday. Rules were given in the registration documents. Question and Answer session will be allocated. In concluding this meeting, the official “Ringing of the Bell” on stage will be the officiating signal that the cooking may start and all teams will then proceed to their sites to begin.

5. CATEGORIES

Categories for amateur competition are Brisket, Ribs, Chicken and Wild Game.

One Grand Champion for each category will be given.

BRISKET-Beef Only

RIBS — Slab only, (spare, baby back, pork or beef)

CHICKEN — Any type- no Cornish Game Hen

WILD GAME — Any meat other than the above categories and this must be listed on your registration form as to what you will be cooking in this category.

6. COMPETITION MEAT

Each of the cooking teams will be responsible for bringing their meat for the competition. It is suggested you bring the minimum quantity of 2 meats per category that you are registered for and turn in your choice of the better one for judging.

7. JUDGING TRAYS

Upon Team check in, a judging packet will be provided to each team. This will include a Styrofoam Judging tray with a hinged lid for each category you have registered in. This is the official judging container that must be turned in with your meat category to the judges. Each container shall only contain one category of meat.

All judging containers shall be clean and free of obvious marks. Marked containers may be disqualified at the Head Judges discretion. Cooks are responsible for insuring that the containers they receive are clean and undamaged. Each Styrofoam judging tray container will have number on it that will be kept confidential to the judges as not to identify it to a specific team. This insures competition fairness.

If a judging tray becomes damaged it may be replaced after it has been turned back into a designated volunteer for inspection. The new replaced container will be given the same number.

8. JUDGING TRAY CONTENTS

The Head Judge will advise all cooks entered into competition the exact quantities and cuts of meat that will be placed into each of the judging styrofoam tray per category. This information will be given at the mandatory cookers meeting and will be posted around the Judge’s area. The bottom of the styrofoam judges container must be lined with silver foil and the meat entry will be placed directly on top of it.

No exceptions will be permitted to the judging rules once posted.

9. GARNISHES

Any and all garnishes and condiments are prohibited in the judging. Meats may be cooked with sauces, but once cooking is completed, sauces cannot be used. No sauce may be visible in the judging containers; this will be grounds for disqualification.

10. TURN-IN TIMES

The Head Judge will set a firm time for the official turn-in times for each category to be judged. Once this time is set and announced to the contestants, no change or variation will be made. The Head Judge will allow a turn-in time window that will be 5 minutes before turn-in time and 5 minutes after turn-in time. Judging trays received after this window time will be disqualified.

These turn in times will be finalized at the mandatory Cookers Meeting.

11. JUDGES

Judging will be done by preliminary, secondary if needed and finals tables. Amount of Judges for tasting will be decided according to the number of entries. All winners will be announced concluding the final judging rounds on Saturday.

All top five entries will be called out in each category in no particular order. Grand Champion will be awarded in each category and awarded the first place prize and trophy.

2nd, and 3rd place winners will be awarded in each category and will be awarded trophies.

14. VOLUNTEER COOKING
